# Planned Giving

## Harris Center for the Arts Society

When making or revising a will or living trust, you should consult with an estate planning attorney. Although it is possible to designate a specific purpose for your bequest or gift (a Restricted bequest or gift), the needs of the college change over time. We request that any specific purpose be stated as a preference, with the final determination left to the discretion of the trustees of Los Rios Community College District.

The Folsom Lake College Foundation is a non-profit auxiliary organization of the Los Rios Community College District, a California nonprofit corporation with a 501(c)(3) IRS designation. Our tax identification number is 94-2506591.

### FOR A WILL (Unrestricted):
